Dear AGW Committee and officials, (Kim Peterson, Steph Lancefield, Sam)

It is with great regret, I must inform you of an issue with the scoring in the AGW Final Cowhorse competition on Saturday night which has a considerable effect on the major placings of this competition. I have been advised that I am required to forward a protest/complaint fee, can you please inform me of where that needs to be deposited.

Please note -

I am requesting that this protest/complaint and the attached evidence is reviewed by independent parties.

So as not to waste anyone's time, I have sought advice and I have been advised that this issue is deemed as warranting an official protest/complaint, is appropriate and carries merit.

The issue is centred around the fact that in the cowhorse section of the AGW final, the Reserve Champion (the second place getter)'s cow clearly goes past the end marker. This should result in a one point penalty. This was witnessed by and brought to my attention by a number of people so it must have been quite clear for people to see it and it s evidenced by numerous photos and videos taken from various angles around the arena, including the video belonging to the second placegetter.

(Please see attached photos, which clearly shows irrefutable proof that the cow is WELL past the marker.)

I would like to point out that this photo was sent to me by the second place getter herself and that I appreciate her integrity and honesty in doing so.

The timing of this protest/complaint is due to the fact that the score sheets were not made public (and have still not technically been made public) within an hour of the class, as required by the ARCHA, even with numerous requests from competitors, so no parties were in a position to be able to confirm discrepancies in a timely manner and before presentations were made.

Once the score sheets did appear late yesterday, some forty hours after the event, I had numerous messages stating that the second placegetter did not get a penalty for the cow going past the marker. The one point penalty she should have incurred would, in fact, alter the placings. The third place getter was on 138, the other competitor would be on a 137.5 once the correct deduction had been made, therefore the placings would have been reversed.

It should be remembered that there is also a very large difference in prizes and winnings at stake here, it is not simply a different coloured ribbon.

I am so very sorry to have to be the bearer of this, it is done with great reluctance and regret and if it was not for the considerable pressure i have been under to follow this through I would much rather have chosen a different path.

I trust that this will be handled fairly, professionally and without any bias or personal repercussions in the future. I am simply acting on advice, in an effort to have an unfortunate but VERY clear mistake rectified.

After our discussions in relation to NRCHA Rule book and NRCHA guide to Protests, I think the event organisers position on this issue is clear.

NRCHA advises:

If the show is complete and the judge has left and there is NOT a videographer, then the results are final.

As the private photo provided is a screen shot of a private video, it cannot be relied upon as evidence to alter the scores & placings. The judge scored this event in real time, and I'm sure applied the same assessment to all competitors.

As there was no official videographer for this event for the judge to review the run, either during the event or at a later stage, the results as they stand, must be considered final.

Situations like this certainly present event organisers with justification to employ an official videographer and charge a video fee to all competitors. For judges to have the option to review a video of any run is invaluable at any event, especially when there is a single judge.
